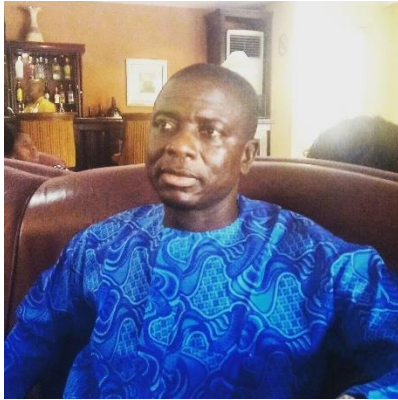

My motivation to join the SEEP Network Board of Directors is driven by four factors as below:

1. The global community today stands at a critical juncture where progress on several SDGs is not on track. SEEP, through its network of leading global organizations can play an important role in designing collaborative strategies that can combine action, advocacy and learning initiatives to accelerate progress on key SDGs around extreme poverty, Hunger, Gender Equality etc. As a board member, I will work with the SEEP Management, in re-imagining how SEEP in future may look like, playing a central role in convening stakeholders, building alliances and cross-sector partnerships and facilitate knowledge exchange for accelerated progress towards SDGs.
2. Being a practitioner from global south, and having worked in the global north and several places in between, across Asia, Africa and North America for over two decades, I not only bring a deep understanding of the socio- cultural and economic systems in different parts of the world, I also bring a deep empathy gained through my immersion in a variety of cultural settings and working closely with diverse stakeholders such as young people, Savings Groups, women entrepreneurs, and social impact organizations etc. This empathetic understanding coupled with my domain expertise in sectors such as enterprise development, inclusive finance, impact investment and digital finance across multiple countries have equipped me extremely well to guide SEEP as it looks to formulate its future strategies and deeper engagement with its membership.
